Only those who have at least three years standing as full members shall be eligible for nomination and election to the Council and office bearers. Self nomination for election to the Council is not acceptable.

Nominations, on the letterhead of the full members or on a white sheet of paper, giving the name, complete address with email id, contact no., membership number and brief Bio-data not exceeding 5 lines of the nominee, along with their consent in writing should be received by the Convenor, Board of Scrutineers on or before 4.00 pm of July 14, 2017 (Friday).

The members who are completing their terms of the Council are eligible for re-election subject to fulfillment of terms as per clause no. 34 & 35(i) of the Articles of Association of the Institute.
